## Federal Grants

**SS4A GRANT:** The Department of Transportation (DOT) Safe Streets and Roads for All (SS4A) program recorded three public "How to Apply" webinars regarding developing an action plan; supplemental planning and demonstration activities; and Implementation Grants. Please visit the [SS4A website](#) to access the webinar recordings and presentations. The first SS4A FY24 application deadline for Planning and Demonstration Grants is on THURSDAY, APRIL 4<sup>th</sup> at 5:00PM EST. For SS4A questions about Planning and Demonstration Grant [visit the FAQs](#).

**TIFIA GRANT:** The DOT's [Build America Bureau](#) released a [Notice of Funding Opportunity](#) for a new program called the [Innovative Finance and Asset Concession Grant Program](#). \$100 million will become available over 5 years to assist public entities in facilitating public-private partnerships and exploring innovative financing and delivery opportunities for [Transportation Infrastructure Finance and Innovation Act](#) (TIFIA) eligible projects. Grants up to \$2 million are available, with the first million requiring no local match. Applications are due THURSDAY, MAY 9.

**PIDP Grant:** The DOT's Maritime Administration (MARAD) published a Notice of Funding Opportunity for \$500 million in Federal FY24 funding through MARAD's Port Infrastructure Development Program (PIDP). On March 5, the U.S. Department of the Treasury (Treasury) issued final regulations for the elective pay mechanism established in the Inflation Reduction Act (IRA). Using elective pay, also known as direct pay, counties and other tax-exempt entities can monetize certain clean energy tax credits that they have previously been unable to access due to their lack of tax liability. On March 5, Treasury also unveiled a new proposed rule to provide criteria regarding the eligibility of certain ownership structures to claim elective pay. During this webinar, counties will hear from Treasury and the U.S. Department of Energy (DOE) on these new regulations and other funding opportunities available under IRA.



Ever wonder why multinational companies invest billions in some counties, but pass by others? ## FROM THE EXECUTIVE DIRECTOR

Governor Murphy recently signed into law **A-4011** (*Calabrese D-36/Wimberly D-35*) (*Sarlo D-36/Scutari D-22*), which will reauthorize the Transportation Trust Fund (TTF), revise the gas tax calculation, and establish an annual fee for zero emission standards. In general, this new law would the State's Annual Transportation Capital Program for 5 years from fiscal year 2025 through fiscal year 2029. The law will authorize \$10.367 billion in capital program expenditures and allows for an average annual capital program of \$2.0 billion per year in years 1 - 2 with a 3% increase on the \$2.0 billion in years 3 - 5 as summarized in the "Transportation Trust Fund Authority" table below. Local Aid to counties and municipalities would be flat at \$400.0 million per year in years 1 - 2 but would increase in years 3 - 5 as outlined in the "Local Aid Annual Allocations through FY 2029" table also below.



Counties will receive an additional Local Aid set aside equal to 25% of the 3% increase in appropriations made to the TTF in fiscal years 2027 – 2029 as follows: \$15.0 million in FY 2027 ( $\$2,000,000,000 * 3\% = \$2,060,000,00 - \$2,060,000,00 = \$60,000,00 * 25\% = \$15,000,000$  and so forth), \$30.5 million in FY 2028, and \$46.25 million in FY 2029.
2. Municipalities will receive an additional Local Aid set aside equal to 25% of the 3% increase in appropriations made to the TTF from fiscal years 2027 – 2029 as summarized above.
3. The Department of Transportation (DOT) and New Jersey Transit Corporation will each receive a set aside equal to 25% of the 3% increase in appropriations made to the Transportation Trust Fund Authority in fiscal years 2027 – 2029.

## FROM THE EXECUTIVE DIRECTOR *(continued)*

Additionally, the new law will impose an increase to the current gas tax of approximately 1.9 cents with a “True-Up” provision based on revenues generated as stipulated in the 2016 TTF law. In other words, the total gas tax imposed on motorists would be contingent on the amount of the tax collected. Please note that the gas tax is comprised of two separate taxes on gasoline and diesel fuel that include the Motor Fuels tax and the Petroleum Products Gross Receipts (PPGR) tax with the current tax at 42.3 cents for gasoline and 49.3 cents for diesel through June 30<sup>th</sup>. Finally, the law will impose an annual fee of \$250.0 on zero emission vehicles with a \$10.0 increase to the initial fee every there until 2028. After that time, the amount of the fee will be set at \$290.0.
